

**Segerstrom Football
Booster Meeting Minutes
December 21, 2023**



- I. Call the meeting to order at 6:40pm.**
- II. Approval of Minutes:** Motioned to approve minutes from Booster meeting held on November 16, 2023 by Vanessa Tagaloa; seconded by Vicky Venegas.
- III. Treasurer's Monthly Report:** Jessica Amezcu presented Reconciliation and Profit & Loss Statement. Motioned to approve by Jennifer Cervantes; seconded by Vanessa Tagaloa. Discussed the approximate profit of \$10, 249.85 for the snack bar for the 2023 season.
- IV. Grad Night Sales:** Jessica Amezcu to spit 2023 and 2024 to be able to see the profit. Will check with Jennifer Valencia to see if she can come 2 times in January to sell tickets. Maribel Barrios can come twice a month --> On January 12th and January 26th, Jessica will help Maribel. We will discuss February dates at the next booster meeting.
- V. Booster Dinner:** Table this for another date (executive members only)
- VI. Car Show:** In May, the Segerstrom counseling team will be putting on a car show. They have asked us to help with being in charge of collecting entrance fees. In exchange, we can have priority in choosing something to sell. Tacos were suggested. We will discuss more at a later date.
- VII. Varsity Banquet, 1/4/24**
Headcount: Money is due 3 days before (12/28/23)
Who will help: Jennifer, Vicky, Vanessa, Jessica, Maribel & Fidel, Alejandra
Time can we start setting up: 3:00pm
Centerpieces: 20 tables. Jennifer to contact a vendor to get prices. Update: Price per table would be \$50, so boosters will just order red roses and put together the centerpieces on our own.
Senior Parents- Dessert table status: Vanessa to email Adi Heraz to check status
Banquet gifts: Vanessa to pick up gift cards, gift bags. We will put together raffle prizes the day off.
-Elk's Lodge will be having 2 food lines this year, instead of 1 to help with the flow.

-Volunteers will be needed to: put together centerpieces, put together raffle prizes, put names on senior banners and tie with ribbon, check-in guests, show guests to their table

VIII. 7-on-7 Schedule: January 20th will be the first 7-on-7 competition. There are several tournaments that Coach Tagaloa would like to enter: Showdown, Quick Strike, 4Vert. Dates for the tournaments start in January until April. We will also have our usual 7-on-7 competitions in summer, with hopefully an away trip if possible during the summer. Boosters want more information about outstanding balances before they approve all of these competitions, which will surpass last year's budget for 7-on-7's (i.e. Grad Night buses, coaches stipends, etc).

IX. Amending By-Laws: Booster members need to read through the existing by-laws to see if there are any items that need to be amended or have additional discussions about. For example, we need to amend the "booster payment" section, but come up with some sort of penalty for not performing assigned duties. It was discussed that all executive members should be at all functions for all levels, regardless of what team their child is on. There needs to be a clear description of booster roles.

X. Nominations for open positions: There are currently no openings for the executive board. However, it was discussed that we need people to be in charge of merchandise, team meals, fundraising, sponsorships. Maribel Barrios and Fidel Garcia volunteered to be the snack bar coordinators for the 2024 season.

XI. Round Table:

- Coaches stipends: Money needs to be transferred to ASB. Coach will forward information along to booster members.
- It was suggested to have a light post-game meal for Freshman games that are far away.
- We need to get information about vendors for merchandise, as there may be a better fit for our needs. We will need to get quotes and inquire.
- Booster members agree that we need to plan events for the season earlier, so that we aren't overwhelmed.
- Fundraising: Jennifer brought up changing prices of sponsorship banners from \$250 to \$500. Also, she suggested starting a VIP club for sponsors who donate at least \$1,000. This could include things such as; a banner, an ad in the program, VIP parking, admission to home games, a VIP sideline viewing area. We would need to clear the last one with Canzone of course. We could call it the "1K Club."
- 2024 Home games: We only have 4 home games this next season (Palm Springs, Valley, Brea Olinda, St. Margaret's).
